




Fig. 1 - Typical Forward Voltage Drop Characteristics




Fig. 2 - Typical Values of Reverse Current vs. Reverse Voltage







Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage




Fig. 6 - Typical Reverse Recovery Time vs. dl_F/dt




Fig. 7 - Typical Stored Charge vs. dl_F/dt





Fig. 8 - Typical Reverse Recovery Current vs. dl_F/dt





Fig. 10 - Transient Thermal Impedance, Junction to Ambient








